Joint Commission Survey Season is here: RMC could have a visit any day

The Joint Commission (JC) is an independent national organization that evaluates healthcare organizations to ensure they meet the highest standards for quality, safety, and patient care. Their surveys help us to maintain certain accreditations that are essential for our ability to serve our community and receive reimbursements.

We are currently in our survey window, which means surveyors can arrive at any of our hospitals without notice.

Surveys are an excellent opportunity to highlight how volunteers are an important part of patient safety and the overall patient experience. Your attention to detail and professionalism will help us make a great impression.

How All Volunteers Can Help Us Shine During the Survey Window and Every Day:

- •Always wear your volunteer badge so it is clearly visible above the waist.
- •Your badge buddy is a great quick reference. Use it if you are unsure about procedures, safety steps or key information. If you are asked a question that you are unsure about, connect the surveyor with a staff member who can help.
- •Follow HIPAA and privacy rules. Never share patient information and avoid discussing patient details in public areas. This includes not asking a patient what procedure they are here to have when they ask for directions.
- •Greet and assist visitors promptly and with a warm smile. Every interaction matters.
- •Follow safety procedures, including proper hand hygiene before and after patient or public contact. Remember no food or drinks should be present during your shift. Water containers must be sealed.
- •Keep public areas and workspaces neat and organized. Clutter-free spaces demonstrate a commitment to safety.

#### **PHS Volunteer Services Annual Test**

Due: November 10th

Thank you for your dedication to Presbyterian Healthcare Services. We appreciate all that you do for PHS patients, providers, members, and staff.

As you may recall, we implemented a new distribution for the annual test - volunteers received reminders on the anniversary month of their last compliance test. This means several of you have already received the email with the link to complete the test online (via Qualtrics.com). Thank you to those of you who have completed this annual compliance requirement. We will continue to send out these monthly reminders until the new volunteer database is up and running.

**COMING SOON:** The new volunteer database platform, VSys, will allow you to complete the annual test on your dashboard page! YAY!

We value your contributions throughout the year to support our patients, their families, and our staff and we are grateful for your continued support. If you have any questions at all, please reach out to any of us. We are happy to answer your questions or provide the support needed to complete this test. Dear Volunteers,

As we enter respiratory season, all volunteers are required to submit:

- Proof of Influenza vaccination or a completed declination form
- Proof COVID vaccination or completed declination form

- Full Name
- Date of Birth
- Last 4 digits of your Social Security Number
- Current Address (including ZIP code)
- Location where you received the vaccines
- Date of vaccination
- The Presbyterian facility where you currently volunteer

▲ **Deadline**: All information and documentation must be submitted no later than **October 31st**. After October 31, volunteers who have not submitted a declination form or immunization record will not be able to return to their volunteer assignment until they do so. Volunteers in patient-facing roles who do not have the vaccination sticker must mask until the end of respiratory season.

Thank you for acting quickly to meet this requirement and for helping us keep our patients, staff, and volunteers safe.
